

## Policy of Anti-Plagiarism

Following anti-plagiarism policies are adopted/implemented as per resolution taken up by the committee members

1. Similarity check for plagiarism shall exclude for the following:
  - (a) All quoted work reproduced with all necessary permission and/or attribution.
  - (b) All references, bibliography, table of contents preface and acknowledgements
  - (c) All generic terms, laws, standard symbols and standard equations.
2. The overall similarity per cent allowed is less than 20%
3. Any thesis/dissertation/project report having more than the prescribed percentage shall be reviewed by the researchers and the concerned advisor till it reaches the permissible percentage.
4. Research work with plagiarism above 20% at PG/Ph.D. will not be accepted and return to the departmental academic integrity panel (DAIP/UAIP).
5. All the departments in College/Institute shall notify a DAIP/UAIP whose members shall be as under :

### Departmental Academic Integrity Panel (DAIP)

### University Academic Integrity Panel (UAIP)

| (d) | Member      | : | A person well versed with anti-plagiarism tools, to be nominated by the Head of institute. |

The Tenure of the committee members including Chairman shall be three years. The quorum for the meeting shall be 3 out of 4 members (including Chairperson).

6. Anti-plagiarism will be applicable to all PG/Ph.D. students with immediate effect.
