Subject: Grant of Dearness Relief to University Pensioners who are in receipt of Provisional pension or pension in RCS (Revised Pay Scale) Rules, 2008 or in 6th CPC.

In pursuance of Govt. of Rajasthan order No.F.12 (3)FD(Rules)/2013 dated 21.09.2021, the Vice-Chancellor is pleased to order that the existing rates of Dearness Relief sanctioned vide university order No. F.4(1-R)(63)SKRAU/C/2014/817 dated 11.05.2020 to the University Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extra ordinary pension etc. shall be revised from 164% to 189% with effect from 01-07-2021

For the purpose of this order:-

- 1 Pension /family pension in the case of Pre-1.1.2006 retirees and where family pension was sanctioned prior to 1.1.2006, means the consolidated pension or consolidated family pension, as the case may be, effective from 1.1.2006 in terms of this office order No.F.4(1-R)()SKRAU/C/2008/746 dated 10.03.2010 as amended vide No. F.4 (1-R)() SKRAU/C/2008/201-10 dated 27.05.2013.
- 2 In the case of pensioners who retire from service on or after 1.1.2006 or where family pension is sanctioned for the first time on or after 1.1.2006, Pension/family pension means the basic pension/basic family pension, as the case may be, in terms of this office memorandum No.F.4(1-R)()SKRAU/C/746 dated 10.03.2010 as amended vide No. F.4 (1-R)() SKRAU/C/2008/201-10 dated 27.05.2013.
- 3 Dearness Relief will also be admissible on the additional quantum of pension/family pension allowed to the pensioners who have attained the age of 80 years and above.
- 4 Payment of Dearness Relief involving fractions of a rupee shall be rounded off to the next higher rupee.
- 5 Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
- 6 This order shall also be applicable in case of Pensioners/family pensioners who are in receipt of provisional pension.
- 7 DR reflects the additional installments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Relief for the period 01.01.2020 to 30.06.2021 shall remain at 164%
- 8 Cash payment shall be admissible from 01.07.2021.
