

**TERMS & CONDITIONS ( Read carefully before placing orders):**

1. The rate contract is valid for brands mentioned against the name of the manufacturers/sole distributors.
2. The order should be given to the manufacturer directly by the purchasing authority with a copy of order to authorized dealer as enlisted in Annexure-I.
3. As per this rate contract, purchasing authority will place orders if provisions of items/materials etc. are specifically mentioned in financial sanction. However, if lumpsum financial sanction is there without mentioning items/materials, the purchasing authority can purchase items/materials costing upto Rs. 2.00 lacs and for higher cost approval of this office will be required.
4. Copy of all the orders placed by competent authority shall be endorsed to Comptroller's office, failing which the order shall be considered invalid and Treasury shall not authorize the bill.
5. The orders will remain valid for a period of one year from the date of issue of this order.
6. **Rates:** The manufacturers have to supply items as per price list submitted by them.
7. **Discount:** Discount on the the price list is to be allowed as per the rate mentioned above. In case of revision in the price list, if prices are reduced then the benefit will be applicable to the University whereas in case of increase in price list, the price list submitted along with this tender will only be applicable.



8. **Delivery:** All the rates are FOR destination where destination means at store of the procuring entity.
9. **Installation:** Installation of instruments, where ever necessary or demanded shall be done by the firm free of cost, as soon as the instrument is supplied.
10. **Guarantee:** Minimum Guarantee/warranty period of instruments/equipments is one year from the date of installation.
11. Excise duty exemption on purchase of equipments/ instruments, etc.should be given as per applicability.
12. Imported instruments/equipments etc. are to be supplied on concessional custom duty as applicable.
13. Taxes as applicable.
14. All other conditions of the contract shall remain as such as given under general terms and condition of the tender.
15. Terms and conditions of RTPP Rule 2013 of State Government will be applicable if not covered above.


