Please send your quotation for the supply and installation of following article(s) from your ready stock under a sealed cover to the undersigned latest by 25.03.2024.

3. Cone penetrometer (Digital)
4. Diesel engine test rig.

**Conditions of Supply**

1. Rate should be quoted for good quality of goods showing the various details of specifications.
2. Rate quoted should be F.O.R. Bikaner and inclusive of all taxes.
3. Supply will have to be made within one month from the date of the order.
4. The tender shall be valid for a period of two months from the acceptance.
5. After a tender has been accepted the rates shall remain valid for the period ending on 31.03.2024. The period can be extended by mutual agreement.
6. No counter proposals or modifications by the tendered will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice, it will be made applicable to acceptance of terms & conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tenders at all.
7. Articles should be strictly accordingly to the specification.
8. Alternative specifications will not be acceptable.
9. Cost of breakage's, shortage and warfare during transaction would be deducted from the relative bills. No extra cost on such on account will be admissible.
10. Quotations received after the prescribed time and date will be summarily rejected.
11. Quotations must be accompanied by an earnest money through Demand Draft in favor of The Agricultural Engineer Central Workshop, Rajasthan Agricultural University, Bikaner without which quotation will not be accepted. Cheque will not be accepted.
12. On the cover containing the quotation should **Above Machine Repair** this office on **25.03.2024 up to 12:00PM**
13. The purchasing officer is not bound to accept the lowest tender.
14. The decision of accepting authority shall be final as to be quality of the stores.
15. Then rejected articles will have to be removed by the tenderers at his own cost.
16. In case of local supplies also the rates should include all the taxes and the University will give no cartage or charges for transportation and the delivery of the goods shall be given at the premises of the university.
17. Quotation should be filled in INK.
18. Remittance charges on payment made to the firm will be born by the firm.
19. The insurance charges will have to be born by the supplier if necessary.
20. No advance payment will be made.
21. All legal proceeding if there is any necessary to institutor any of the parties (University of counterpart) shall have to be lodged in courts situated at Bikaner

22. Tenderers will have to submit Income Tax Clearance certificate from the Income Tax Officer of the circle concerned. Without clearance certificate tender will not be accepted.
