ORDER

Subject : Grant of Dearness Relief to University Pensioners.

In pursuance of Govt. of Rajasthan order No.F.12(8)FD(Rules)/2017 dated 25.10.2021, the Vice-Chancellor is pleased to order that the existing rates of Dearness Relief sanctioned vide university order No. F.4(1-R)(63)SKRAU/C/2018/304-43 dated 06.08.2021 to the University Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extra ordinary pension etc. shall be revised from 28% to 31% w.e.f. 01.07.2021.

For the purpose of this order:-

1. Pension /family pension in the case of Pre-01.01.2016 retirees and where family pension was sanctioned prior to 01.01.2016, means the Revised Pension or Revised Family Pension, as the case may be, effective from 01.01.2016 in terms of this office order No.F.4(1-R)() SKRAU/C/2017/678-713 dated 08.11.2017 as amended vide No. F.4(1-R)()SKRAU/C/2017/1278 dated 22.12.2017 and No. F.4(1-R)()SKRAU/C/2017/ 627-63 dated 03.7.2018.
2. In the case of pensioners who retire from service on or after 01.01.2017 or where family pension is sanctioned for the first time on or after 01.01.2017, Pension/family pension means the basic pension/basic family pension, as the case may be, in terms of this office memorandum No.F.4(1-R)()SKRAU/C/2017/678-713 dated 08.11.2017 as amended vide No. F.4(1-R)() SKRAU/C/2017/1278 dated 22.12.2017.
3. Dearness Relief will also be admissible on the additional quantum of pension/family pension allowed to the pensioners who have attained the age of 80 years and above.
4. Payment of Dearness Relief involving fractions of a rupee shall be rounded off to the next higher rupee.
5. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
6. This order shall also be applicable in case of Pensioners/family pensioners who are in receipt of provisional pension.
7. Cash payment shall be admissible from 01.07.2021.
