4. No counter proposals of modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice. It will be made applicable to acceptance of terms and conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tenders at all.
5. Work should be strictly according to the specification.
6. Quotation received after the prescribed time and date will be rejected.
