Calling the meeting to order, the Hon'ble Vice- Chancellor welcomed the members to the 17<sup>th</sup> meeting of the Academic Council.

AU/AC-17/2002-1/01 To consider the minutes of the Academic Council meeting held on 16.7.2001 and 18.1.2002.

Resolved that the minutes of Academic Council dated 16.7.2001 and 18.1.2002 be confirmed with the following modifications:-

(i) Item No. AU/AC-16/2001-2/9(2)  
Following 3 formula were approved in previous meetings of Academic Council

1.  $y = (50 - 10x) + 5x^2$

2.  $y = \frac{4x}{Z}$

3.  $y = (x - 7)x^2$

At the time of last Ph.D. admission on 10<sup>th</sup> & 11<sup>th</sup> Jan., 2002 at Jobner above formula were used to evaluate the academic performance in M.Sc. degree obtained from different universities but it was observed that formula No.2 and 3 were not found appropriate and Admission Committee decided to follow formula No.1. Therefore in the present context, out of above mentioned 3 formula, formula No.2 and 3 be dropped and formula No.1 be followed.

Further, the corrections/additions in Post Graduate Studies regulations 2001 suggested by Dean, PGS, were considered & approved.

- (i) Six NRI paid seats in UG programme as additional seats be created with reservations as per policy applicable. Payment seat should be fixed as Rs. 1.00 Lac per professional programme, i.e. 5 lac total without any stipend in internship. They will have to pay regular fees as usual and as applicable. Any student failing in any programme would have to pay additional amount for that year.
- (ii) For the programmes, one seat per discipline be kept as paid seat following reservation policy as per roster system. Payment rate should be fixed as Rs.30,000/- per semester for programme of 4 semester. For any extra semester, the candidate would have to pay additional amount for that semester.
