The Vice-Chancellor while welcoming the members to the meeting held at University headquarter expressed satisfaction and wished that the constructive approach by one and all would pave the way for rapid development of the Agricultural University located in the environmentally handicapped state and provide viable support to line departments.

Considered the confirmation of minutes of the meeting held on 29th July, 1991.

Minutes of the previous meeting held on 29th July, 1991 at Agricultural Experiment Station, Durgapura (Jaipur), were confirmed with the following modifications according to the comments received from various members:

- B. The deci-sion in respect of item No. 315 has been taken under item No. 313.
- C. The word "Bank" be read in place of 'Board' under item No. 320 (47) in line number 6.
- D. Rupees 2492.50 be read in place of Rs. 2492.30 under item No. 324-line number 2.
- E. The various orders passed by the Hon'ble Vice-Chancellor reported under item No. 325 have been noted under item No. AU/BOM-21/91-2/300.
- F. The amount of Rs. 2550.00 be read in place of Rs. 2250.00 appearing under item No. 326 in line 3rd.
- G. The sequence of item No. 325,326,327,328, 329 be read as item No. 326,327,328,329 and 330-A respectively.

Considered report regarding review of action taken on the minutes of the last meeting of Board of Management held on 29.7.1991.

With respect to action taken on different items which arose during the deliberation on last meeting the progress was reported but the Board members expressed dismay at number of points as to why action has not been taken. The Vice-Chancellor apprised that perhaps it was communication gap and he has not been able to see the agenda items and notice there of on account of preoccupation first of all with the career advancement committee and later on selection committee meetings upto the last minute.

Regarding Mechanised Agri. Farm, Umedganj, Kota which is running in loss.

The Vice-Chancellor also showed the members proceeding of the meeting in which the Director (Research) was asked to take action in compliance of the item No. 298 (4). Much needed progress in this direction in fixing the responsibility for gap between revenue receipt and deposits in the University account could not be made for want of competent accountant. Nevertheless, concerned officers are being asked to take up the issue on priority and submit report in no case later than before the next meeting of Board of Management is held somewhere in the month of December, 1991. The relevant decision taken in the seed farm advisory committee meeting were despatched on and resolution reproduced:—

COMPTROLLER

ACTION-

The Seed Farm Advisory Committee noted with great concern the difference between the receipts of Agricultural Mechanised Farm, Ummaidganj since the year 1980-81 and the deposits made in the University fund accounts. The reasons for this large difference are not easily understood. Therefore, it should be found out how this descripancy arose and who is accountable for this. Two years in which there is a difference of over 10 lakhs in receipts and deposits should be taken up for investigation by coordinator, MSP and Director(Res.). It was recommended that in future the deposits to the University fund accounts should always tally with receipts of the farms. The receipts should be transferred immediately next day to University fund account. This huge descrepancy in receipts and deposits in the year 1981-82 and 1985-86 is alarming and speaks volumes about mismanagement of funds.

ACTION-Director(Res.) and Coordinator, NSP and F.S.

Committee could not be constituted for want of nomination of M.L.A. at that time.

(a) Disapproving the case of leave encashment for 240 days.

Require no action.

(H) Approving to accept the scientists on deputation.

The Vice-Chancellor expressed that some of the outside scientists contacted to man various positions in different subjects did not show keenness to join this University on the existing emoluments. It was, therefore, decided that the scientists taken on deputation be provided rent free accommodation plus 10% of the basic pay as allowance. This provision should cover ICAR, SAUs and State Government only.

() Regarding constitution of committee for preparing perspective plan.

The issue of preparing perspective plan has been hanging since long. The members expressed serious reservation about delay in its finalisation. It was, therefore, decided that a copy of the perspective plan prepared earlier be handed over to Dr. N.S. Randhawa, Ex-Director General (ICAR) and member of the Board of Management, Mr. R.S. Kaushal and Dr. G.S. Shekhawat who would convey their opinion as early as they can. After receipt of their opinion a cogent picture of the perspective plan would be submitted in the next meeting of Board. In pursuance of this resolution copies of the plan prepared earlier were handed over to them.

(JT) Regarding granting recognition to class IV employees Union.

It was decided to grant recognition to the Class IV employees Union.

While taking up the issue on the constitution of committee to examining grants received from ICAR during 1985-90, the members again expressed dismay at inordinate delay in collection and submission of information. The Comptroller was therefore, advised to submit the report on the quantum of assistance provided by the ICAR under Agricultural University Development Plan and all the members desired that the information should be made available before the next meeting of the Board of Management.

(4) Regarding determining the seniority of teachers.

Regarding determination of interlaced seniority of the teachers. Board members wanted to know as to what purpose would be served by determining the seniority of teachers in different disciplines. After thorough deliberations it was decided that the rules framed in this case earlier in Sukhadia University at the time when RAU was part of the Sukhadia University be put up for determining inter-lace seni-ority. Though and this would not confer much advantage /seniority of

(<2) Regarding draft service rules for the University employees.

The draft service rules prepared for the employees were sought to be circulated but it was emphasised that prior to its circulation it should be examined by the Registrar and Comptroller and then put up to Vice-Chancellor who will after his observations put up the report in the next meeting of the Board.

(%) Regarding allotment of land for NBSS & LUP scheme transferred to Udaipur from Baroda.

With respect to decision on item 299 (H_b) the information was submitted and it was found that the land at the RCA, Udaipur premises is inadequate and therefore the land should be provided only to house the laboratory and not to build complex. It should, therefore, be left to the National Bureau of Soil Survey and Land Use Planning to have the land for building laboratory in RCA premises and residential and other buildings in the new campus close to CTAE or all buildings in the new premises.

(Z) Demanding the list of officers/employees/ teachers who are to retire during the next 5 years for considering the matter of providing the medical facility.

Though the information has been sought yet much needed information in respect of employees likely action - REGISTRAR (Estt.Gr.I & II) collected. The Board desired that information be collected forthwith from the available records and placed in the next meeting of the Board.

(8) Regarding collecting information from other Universities and ICAR for revising the rate of University contribution towards P.F.

The item was not discussed on account of implementation of pension scheme in lieu of P.F.

(VT) Regarding placement of extension activities by dividing in 3 regions.

Regarding placement of extension activities the ACTION draft regulation covering the ZREAC activities in different (A.R.-Gen.)
SAUs issued by the Secretary, Deptt. of Agriculture and
Cooperation, GOI and endorsed by the DG(ICAR) and World
Bank were placed on the table of house and it was resolved
that there will be 9 agroclimatic zones in place of earlier
proposal of 3 and the Associate Directors(Research) of the
zones will coordinate the activities of University research
and extension and also of the Deptt. of Agriculture with
respect to reviewing the progress of research work including
research programmes for next session, work out production
recommendations, review farm trials and report on various
other aspects including feed back.

Considered the issue of submitting proposals of delegation of powers to Deans/Directors in accordance with model published for NARP by the ICAR.

The Vice-Chancellor briefed the members about proposed

delegation of financial powers to Deans and Directors in accordance with the model laid down in NARP manual. The Vice-Chancellor throw light on this issue making it clear that the manual was prepared 13 years ago and cost esca-lation has gone so much that even if we implement this, it will not serve much purpose. Accordingly he suggested that we plan to authorise all OIs of the stations, ADRs and DR to exercise full financial powers subject to the budgetary ceilings.

1. It was also made clear that advance payment can be permitted against railway receipt but not (transport) against goods receipt/which shall, however, be done by the DR, DEE and Deans of the Colleges under their jurisdiction.

It was further made clear that sanction for advance payment for purchasing foreign journals from professional societies can also be issued by officers covered in i if they are not procured through intermediate agencies. However, books and journals intended to be procured through intermediate agencies will not be included and in this case payment will be made only against delivery as per

regulation of Good Office Committee.

ACTION -COMPTROLLER

4. The Vice-Chancellor also emphasised that it shall be the duty of Deans and Directors to report the action taken on commissioning of equipments procured indigenously or from abroad within 3 months time and in no case after the warrany period so that it could be referred to the party to set right the defect. Failure to do so will invite disciplinary action against erring officers.

5. It was also decided that if some of the items which are of common use like liveries, stationery, plant breeding appliances, selfing bags, glasswares, chemicals and equipments the University will enlist the firms and circulate to different colleges and stations and the rates will be decided FOR destination as far as possible to maintain uniformity.

Dr. N.S. Randhawa expressed deep concern on inordinate delay in preparing annual report of the University for several years. So far the University could prepare the annual report for 1988-89 session and therefore it is running two years late. The Vice-Chancellor assured the members that the report for 1991-92 shall be submitted in time but those for 2 years in between

will also be tried to be submitted though owned no responsibility for past. There has been some slackness on this part in preparing the Annual Reports as the budget etc. in the past were passed perhaps without Annual Report. It was assured by the Vice-Chancellor that Annual Report completed in all respect giving salient findings in research work, toning of administration, bringing improvement in teaching, research and extension programme including the new ifrastructure created will be submitted henceforth in time.

The members expressed dismay at the inordinate delay for submission of the report in the University in time.

Dr. G.S. Shekhawat volunteered to get prepared the report if the information is sent to him. It was, therefore, decided if the University is unable to prepare the report for 1989-90 and 1990-91 it may handover the work to Dr. Shekhawat, member of the Board of Management. The Vice-Chancellor, however, promised to get the report for 1991-92 in time and submit it to the Board of Management before budget for 1992-93 is passed and he assured that in future all the reports will be presented as per statutory requirments before the budget is approved. Since this is technical part, the work will be handled by different Directors and Deans and Director of Research will work as Coordinator.

ACTION-Deans and Directors and Dean, Post Graduate Studies, all of them will send the report to Director (Research) who will compile it and send to the Editor (Research) at the University headquarters for final vetting by the Vice-Chancellor. The report for 1989-90 and 1990-91 are also to be prepared. The Editor (Research) will take up the preparation of the reports with the help of Deans and Directors and submit it to the University before the next meeting of the Board and if not possible directives shall be issued to different Units to pass on the information to Dr. G.S. Shekhawat and/or authorize him to get the same from different units.

- (2) On a query as to whether Dr. Rajveer Singh is senior to other professors who has been appointed as Dean, CTAE, Udaipur, the Vice-Chancellor stated that before his appointment another professor was asked but he stated that he would not be interested to work as Dean and therefore Dr. Rajveer Singh was appointed as Dean, CTAE, Udaipur as per normal terms and conditions.
- (3) There was much discussion on the removal of Dr. P.R. Jatkar as Dean of CVAS, Bikaner and appointment of Dr. U.K. Vyas. It was brought to the notice of the members that Dr. P.R. Jatkar has already completed 3 years term and it became inevitable to streamline the administration and improvement of the College. He also made it clear that if the performance of the Deans and Directors is not satisfactory even contingency measures will be taken to remove them before completion of term but in any case he assured the members that all such proposals will be brought before the Board and/or the Academic Council otherwise they will be informed by circulation.

Chancellor assured that Dr. M.S. Manohar will continue as Chairman, Faculty of Agriculture till he remains the Dean of the College as he is the seniormost Dean at the present. It is usually regarded that once a person ceased to be Dean of the College he also ceased to be the Chairman of the Faculty and orders issued do not vitiate this procedure.

Transfers/postings

(10) On item 10 of this, the Vice-Chancellor told the agitating member Dr. K.B. Sharma that the arrangement has been made in the larger interest and simple transfer does not mean any punishment. Perhaps Dr. G.L. Sharma will have better chance for career advancement in Nematology at Udaipur where teaching work is done.

The Chairman also made it clear that Heads of the Departments shall be appointed from amongst staff at teaching campuses and not research station. He lamented over the ignorance of the members on this issue.

Leave

On query as to whether the Technical Assistants as non-teaching staff is entitled for study leave, it was informed that they are entitled and this way the University shall be promoting the cause of supporting staff to update and improve their qualifications. This, however, will not entitle them for automatic promotion, which is a separate process in itself.

After much discussion on the issue it was resolved that the post of DSW be filled up regularly by inviting applications from within the University system as no regular appointment of Dean Student Welfare can be made unless the statutes governing that are ammended.

Fatehpur, Jalore, Navgaon and any other far flung station which handicaps the employees in one or other way and make living difficult and cost prohibitive, subject to the availability of the accommodation.

The proposal of providing rent free accommodation as existed in the Sukhadia University in respect of some categories of the staff, which were, by and large, of agricultural wing was considered and it was resolved that the rent free accommodation be provided to workers of all covered earlier subject to the condition that the houses are available for that purpose. The university will not hire the houses for this purpose and incur liability.

Since the houses for this were provided by the ICAR on 100% assistance and this incentive of providing houses subject to availability would perhaps alleviate their untold miseries and it was therefore resolved that rent free accommodation to the entire staff be extended to staff posted at Agricultural Research Stations, Fatehpur, Navgaon, Jalore, ARSS, Sumerpur, ARSS, Diggi, LRS, Chandan/Nohar, University Mechanised Farm, Rojari and Date Palm Research Centre at Bhojka and NARP Centre, Kodamdesar subject to availability.
