## Comptroller

Dr. (Mrs.) Asha Shivpuri and Secretary (Animal Husbandry) conveyed their inability to attend the meeting. The Secretary (Agricultural Production), Secretary (Higher Education) and the Director of Agriculture, Govt. of Rajasthan, could not attend the meeting.

The Vice-Chancellor accorded a cordial welcome to the members. He stated that BOM meeting is always held at University Headquarter, Bikaner. This time, in order to acquaint with the various activities of this campus to the members, the meeting has been convened at Udaipur. The Vice-Chancellor accorded special welcome to Dr. S.L. Mehta, DDG (ICAR) and Dr. E. A. Siddiq, National Professor (Rice Research) with the remarks that these renowned scientists with their technical expertise and intellectual leadership would provide valuable guidance in development and progress of the university. Their association will immensely upgrade the capacity of the Board to take valuable decisions for shaping the University in a spirit of cooperation and goodwill to contribute in its over-all development.

The Vice-Chancellor highlighted some of the important events which took place during recent past with special reference to the progress made under ADP. He informed that the work of civil construction in ADP has got three different components, (a) Construction of 110 quarters at Beechwal Campus, Bikaner, is progressing satisfactorily and it is hoped that all the quarters shall be completed before the stipulated time, i.e. March, 1998, (b) Construction Work outside Bikaner assigned to Rajasthan State Agricultural Marketing Board is also making speedy progress and out of 16 items in different locations, work at 10 sites have already been started and at remaining 6 sites, it is expected to be started by the end of this month, (c) For the civil work at main campus (Bikaner), for seven different items the World Bank has cleared all except one i.e. construction of an auditorium. The construction work of the Institute of Agro-Business Management and Academic Staff College at Bikaner have already been started and for remaining



items work will start in a couple of weeks time. For furnitures & fixtures of the buildings to be constructed under ADP & on account of escalation of prices World Bank has agreed to provide additional funds of Rs. 13.00 crores.

The Vice-Chancellor emphasised that if the cash flow is regular from the state government to the University, all the ADP work shall be completed within the stipulated time, i.e. March, 1999. He, however, pointed-out that at present on account of financial crunch at the state government level, University is not receiving required funds, which is a biggest bottle-neck in the progress of ADP and other activities under Plan and Non-Plan projects.

He said that RAU has taken a great leap-forward in the Landscape work at University and other campuses, through which plantation work is being undertaken in a planned manner. He informed the members that in Veterinary College the intake capacity has been increased from 80 to 130 students and therefore, the College is facing problem to cope up with the teaching load. It is necessary to pay immediate attention to acute shortage of staff, class-rooms, hostel accommodation and other facilities at the College.

Dr. S. L. Mehta, DDG (Education) ICAR, assured that ICAR will extend full support in the development of RAU. He said that with the implementation of ADP, RAU will be lifted to a Centre of Excellence. He also said funds, directions and management are three most important issues that dominate policy needs in Higher Education, Research and Extension. Admiring the presence of Dr. Siddiq, as member of the Board, Dr. Mehta advised to use his vast experience.

Dr. Siddiq remarked that RAU has proud privilege to have Dr. Pradhan, an internationally acclaimed scientist, as its Vice-Chancellor. He said that Dr. Pradhan is a fine academician, administrator and great human being and he is confident that RAU would make rapid progress in agriculture research and education under his leadership. He assured that he will extend his support to fulfill the goals of the University.

Shri Mahaveer Bhagora thanked the Vice-Chancellor for holding the BOM meeting at Udaipur. The regular agenda items were then taken up as follows :-

Confirming the proceedings of the meeting of the Board of Management held on 03.11.1997.

The proceedings of the last meeting of the Board of Management held on 03.11.97, were confirmed with the following observations :-

1. Comments received from Dr. C.P.S. Yadav, were discussed and it was decided that the word "after following the prescribed procedure" be added in the last line "shall be regularised in due course" in resolution No. AU/BOM-38/97-2/653. The Vice-Chancellor further desired that if any member wants to discuss any policy matter in the Board, the same along with the details be sent to the Registrar well in advance before the meeting is held, so that the same could be circulated to all the members along with the agenda.



2. A copy of RAU Act and Statute should be sent to all the members of the Board.
3. Sabbatical leave rules adopted by ICAR be put up for consideration in the next meeting of the Board for implementation at this University.

Reporting the action taken on various resolutions of the Board of Management meeting held on 03.11.97.

The reporting on the action taken was noted with the following observations :-

1. Resolution No. AU/BOM-38/97-2/652 : In the committee appointed for finalising the Draft Service and Financial Rules of the University prepared by M/s. A.C. Sharma & Associates, Jaipur, Shri N. Parthsarthy, former Financial Advisor (ICAR) may be associated for examining the financial rules of the University.
2. Resolution No. AU/BOM-38/97-2/658 : A team of 2-3 Scientists be sent to Dapoli, to learn the technology adopted by them for increasing the farm revenue. Efforts should be made to adopt the same model at RAU also, for increasing the farm income at various Instructional, Research and Mechanised Farms.
3. Resolution No. AU/BOM-38/97-2/664 : The matter of confirming the orders passed by the Vice-Chancellor, regarding punishment to students for using unfairmeans in the University Examinations by the Board of Management be reviewed.

Reporting orders passed by the Vice-Chancellor.

Resolved that orders passed by the Vice-Chancellor be confirmed.

Reporting the Govt. Order No. F.1(1)/Sani./97, dated- 27.08.97, posting Shri S. N. Vyas, as Estate Officer of this University in place of Shri N. L. Damani.

The Board confirmed the above order.

**AU/BOM-39/98-1/677**

Considering the request of Smt. Rajni Yadav W/o Late Dr. J. S. Yadav, Ex-Associate Professor, CVAS, Bikaner, for making payment of Rs. 1.00 Lakh instead of Rs. 30,000/- as per Revised Welfare Scheme, 1996.

Resolved that Smt. Rajni Yadav W/o Late Dr. J. S. Yadav, Ex-Associate Professor, CVAS, Bikaner, be paid Rs. 1.00 Lakh instead of Rs. 30,000/- as per Revised Welfare Scheme, 1996, since the option form of late Dr. J. S. Yadav, was received in the office within the stipulated time.

The members desired that other similar cases if any, may also be treated at par.

**AU/BOM-39/98-1/678**

In pursuance to Board of Management Resolution No. AU/BOM-35/96-3/625, dated- 30.09.96, through which the pay of Shri S. P. Purohit (Horticulture) has been notionally fixed in the pay-scale of Rs. 3700-5700, w.e.f. 1.1.86, on humanitarian ground, similar cases need consideration.

After detailed discussions the members were of the view that there should be no departure from the rules framed by U.G.C. and further conveyed by ICAR to the University. In order to provide natural justice to all such teachers and to avoid discrimination and maintain parity it was resolved that :-

1. All those Associate Professor selected by a Statutory Selection Committee with a condition that they will start earning increments only after obtaining their Ph.D. degree and subsequently have obtained the Ph.D. degree be allowed notional grade increments w.e.f. 1.1.86/the date of joining, as Associate Professor and be paid grade increment from the date they have been awarded Ph.D. degree.
2. All those Associate Professors selected by a Statutory Selection Commission with a condition that they will start earning increments only after obtaining their Ph.D. degree and have not yet completed their Ph.D. degree, a Screening Committee be appointed by the Vice-Chancellor to review their cases to determine whether such persons does



possess to their credit research work/publications equivalent to Ph.D. degree. After evaluation by the above committee, if found eligible, such teachers be given notional increments, w.e.f. 1.1.86/date of joining as Associate Professor, and be paid grade increment w.e.f. 1.1.96.

**AU/BOM-39/98-1/679**

Considering recommendations of the committee constituted to examine the matter of removal of Shri Pema Ram occupying unauthorised possession in the premises of College of Agriculture, Bikaner.

Resolved that the Vice-Chancellor be authorised to negotiate the matter with Shri Pema Ram, through a committee to decide about the compensation to be paid to Shri Pema Ram and get the unauthorised encroachment vacated.

1. She should stay in the hostel and no male family member is allowed to stay with her.
2. Two years experience of working in a girl's hostel.
3. Managerial experience will be given preference.

1. Law Graduate from a recognised University established by Law in India or its equivalent with three years course of professional degree in Law.
2. Good Knowledge of Hindi and Rajasthani culture.
3. Two years experience of working in High Court.

Considering qualifications for the post of Coaches (1640-2900) in the University Sports Board.

Resolved that following qualifications for the post of Coach in the pay-scale of Rs. 1640-2900, be approved :-

Graduate from a recognised University with Diploma in concerned game from National Institute of Sports.

Considering Notification No. F.5(51)/Personnel/K-II/88, dated- 31.12.96, issued by the State Government revising the rules for providing employment to the family member of the deceased employee. The Board of Management has adopted Government rules during 1990, as notified vide letter No. F.3(6)/Personnel/K-II/75, dated- 29.09.75.

Resolved that the revised rules conveyed by the State Government for providing employment to the family members of the deceased employee, vide Notification No. F. 5(51)/Personnel/K-II/88, dated- 31.12.96, be adopted by the RAU, with immediate effect.

Considering the services rendered in autonomous organisations of the Central/State Government, in case of the new entrants in RAU, for the purpose of Pensionary Benefits.

Resolved that the services rendered in other autonomous bodies of State/Central Government be counted for the purpose of Pensionary benefits provided that all benefits of such employee are transferred to RAU, as per rules.

Resolved that the following qualifications for the post of Lab. Assistant in the pay-scale of Rs. 1200-2050, as prevailed in the state government be adopted:-

Higher Secondary/Senior Higher Secondary or its equivalent examination passed with Science including Agriculture Science from a recognised Board/University.

Considering the revised Draft RAU Rules for allotment of Residential Accommodation, 1997, after examining the suggestions of Sh. N.S. Parihar, Member of BOM, in pursuance to resolution No. 636, dated 15.2.97.

Resolved that the RAU Draft Rules for allotment of residential accommodation, 1997, be approved with the following modifications:-

#### **VI. RESERVATION OF ACCOMMODATION/OUT OF TURN ALLOTMENT**

- a. Nomenclature of Superintendent of Physical Education be read as Assistant Director (Physical Education).
- b. This rule be replaced as under:-

The house allotment may be considered on out of turn basis in exceptional case by the Vice-Chancellor depending upon the merit/justification/essentiality of services of such case at different locations on the recommendation of the committee consisting of the following:-



(i)	Senior most Dean/Director	Chairman
(ii)	Registrar	Member
(iii)	Concerned Dean/Director/ADR/ Head of the Unit	Member
(iv)	Estate Officer	Member Secretary

Out of turn house allotment may not exceed 2% of the total residence categoriwise.

#### IX. RETENTION OF ACCOMMODATION

(d) Following be added:-

If any employee is transferred from a Unit located in urban area to a place of remote area, such employee may appeal to the Vice-Chancellor for retaining the house for a specified period to be decided on the merit of the case so that his family is not deprived of with the educational and medical facilities.

Resolved that the grace be passed in respect of the candidates who have completed the requirement for the award of degree of Doctor of Philosophy (Ph.D.) by thesis or course work as per Appendix - I.

**AU/BOM-39/98-1/689**

Considering recommendation of the Screening Committee meeting held on 26-27th December, 1997, in the faculties of Agriculture, Agricultural Engineering, Veterinary & Animal Science, Dairy Science and Home Science, for allowing Senior/Selection Scale to the teachers of the University under Career Advancement Scheme.

Resolved that the recommendations of the Screening Committee meeting held on 26-27 December, 1997, in the Faculties of Agriculture, Agricultural Engineering, Veterinary & Animal Science, Dairy Science and Home Science, for allowing senior/selection scale to the teachers of the University under career advancement scheme be approved, as per Appendix - II, with the following observation :-

The recommendation in respect of Shri Sukhpal Singh, Assistant Professor (Plant Breeding & Genetics) Agriculture Research Station, Durgapura, for granting him selection scale be deferred.



**AU/BOM-39/98-1/690**

Considering the appeal No. CHS/PA/0497-423, dated- 02.08.97, of Dr. (Mrs.) C. Dave, presently working as Dean, College of Home Science, Bikaner, for revision & review of the decision conveyed to her vide order No. F./RAU/Estt/Gr.I/94/27-87, dated- 27/30.08.94, and order No. F. /RAU/Estt/Gr.I/94/640-50, dated- 29/30 Sept. 94, with-holding three increments and granting her EOL from 01.01.92 to 30.09.94.

The appeal submitted by Dr. (Mrs.) C. Dave, presently working as Dean, College of Home Science, Bikaner, was considered thread-bare. The members were of the view that as per Service Conditions of Teachers and Conduct Rules, no employee of the University can take employment elsewhere without prior & proper sanction of leave and grant of permission by the University. It was not proper on the part of Dr. (Mrs.) C. Dave, to leave the office without permission and serving as Senior Advisor, Social & Human Resource Development, RAJAD, Kota. However, since the RAJAD project was a joint venture between Canada Govt. (sponsored by CIDA) and Govt. of India and RAU was one of the Indian Executing Agency on behalf of GOI, and the University did not communicate any decision on the application of Dr. (Mrs.) C.Dave, in time for her deputation and grant of suitable leave, it was decided that office order No. F. /RAU/Estt/Gr.I/94/504-14, dated 21.9.94, be modified as under:-

1. For disobeying the University orders and violating service & conduct rules of the University one increment of Dr. (Mrs.) C.Dave, be withheld with cumulative effect.
2. She may be issued a recorded warning not to repeat such action in future.

Secondary or its equivalent recognised by the Govt. with certificate/diploma in the trade recognised by Govt.

4. Consideration of regularisation of services of such persons who were initially appointed on adhoc basis, but subsequently regularised after taking their job test /interview and now requesting for regularising their intervening period be deferred for providing details of such cases.




