At the outset the Vice-Chancellor welcomed the new members Shri K.M.Mehta and Shri Suryadeo Singh Barhet, who were attending the meeting of the Board for the first time. The Vice-Chancellor expressed that Rajasthan Agri. University, Bikaner shall definitely be benefitted from the vast and long experience possessed by Shri Mehta and Shri Barhet. With their presence deliberations in the meetings will be more meaningful and constructive.

The regular agenda was taken up thereafter.

(i) In the introductory part of the minutes at (e) wherein it has been reported by the Vice-Chancellor that Government orders/decisions for grant of U.G.C. Pay Scales of R.700-1600 to Lecturers granted under Supreme Court Order has not been received so far, the following may be added:

- (I) All adhoc lecturers fixed in the UGC pay scales through the Supreme Court order may be appointed till further orders in place of extending their term after every 3 months.
- (II)All the lecturers who have been fixed in the UGC pay scales of &.700-1600 through the Supreme Court order shall have to face interview in view of the fact that ultimately after the Govt. sanction is received, these posts are to be up-graded to that of Asstt.Professors. This has become necessary because selection on the posts of Asstt.Professors is a statutory selection as per provision of the Act.

Considered the Revised Estimate for 1987-88 and Budget Estimates for the year 1988-89 for Rajasthan Agriculture University, Bikaner.

RESOLVED that Revised Estimates for 1987-88 and Budget estimates for 1988-89 may be approved with the observations that as and when grants for State/ICAR etc. are finalised in a meeting of Board of Management discussions and suggestions, if any, may be held at length. The Vice-Chancellor informed the members that the State Plan ceiling fixed earlier by the State Government has been reduced from Rs. 250,00 lacs to Rs. 200.00 lacs in Agriculture sector, Rs. 26.00 lacs to Rs. 25.00 lacs in animal husbandary sector and R.5.00 lacs to R.4.50 lacs in technical education sector. With these cuts development of newly established RAU will be showed down. As regards posts for University Administrative office the Board authorised the Vice-Chancellor to take up the matter with the State Government. Keeping in view the budget and work load of RAU the Board desired that adequate number of administrative, ministerial, technical and class IV posts be made available, for the University Administrative office, RAU, Bikaner.

As regards the post of Director, Planning and Monitoring approved in meeting of 14.9.1987 the Board desired that State Govt. may be requested for creation of this post on priority basis. Further the Board approved creation of the post of Dean, Students Welfare. Meanwhile some alternate arrangements may be made by the Vice-Chancellor so that the work on this account may not suffer.

While discussing the budget some members pointed out that academic achievements(achieved in various fields of Agriculture and allied sectors) vis-a-vis the expenditure incurred under various budget heads of non-plan of the University be reviewed. After detailed discussions it was resolved that following committee may be appointed to submit a report about the achievements, reutilization of staff and identification of areas of importance and priorities for research according to State needs. Further the committee may also advise for prospective plans of departments in consultation with Heads of the Deptts, ADR's, Directors of Research & Extension and Deans of Colleges.
