- (i) Since no staff member is willing to stay at ARS, Kumher the need to continue the station may be examined and put up to the BOM in its next meeting.
- (ii) Financial Liability be properly reviewed by Dir.Res. for ARSs, Pratapgarh.
- (iii) No rent free facilities to employees at ARS, Kota be approved.

Overall review of all such cases be taken into consideration.

The matter of advance payment against goods receipt other than railway receipts be examined again by the comptroller and put up in the next meeting of Board of Management. Reply given was found to be not satisfactory.

Matter of revised rates of remuneration to be paid to the Chartered Accountant of the University for conducting the audit be kept pending. Details of the payment made to the Chartered Accountant of RAU for the last five year's be put up before the BOM in its next meeting.

The matter of granting increments to those Associate Professor's selected by the Statutory Selection Committee with the condition that they will start earning increments only after obtaining Ph.D. degree and they have not yet obtained Ph.D. degree was discussed in detail and decided that such Associate Professor's be treated as deemed to have been appointed as Assistant Professor and they be granted benefit of increment from the date they become entitled Under Career Advancement Scheme for the Selection Scale. This decision will be applicable in the present five pending cases only. A proposal with financial implication be prepared and put up in next meeting of BOM.

1. Order's for establishment of Vigilance cell be issued and reported in Board of Management.
4. Qualification of Teaching Staff/Director and courses for Faculty of Agro-business Management be got approved from Academic Council and Hon. Chancellor requested to accord approval for recruitment on these post.



5. Executive order's for opening a counter to facilitate farmer's of the area for improved seeds be issued immediately. Targets be fixed for distribution of foundation/improved seeds/plants and such facilities be provided at all ARS/ ARSs and KVKs. Wide publicity of this act be done by the respective Directors.
6. All out efforts be made for commencement of Post Graduate Classes in all the subjects of Agriculture and Home Science Faculty at Bikaner. Proposals submitted to State Govt. for upgradation of Home Science College and College of Agriculture, Bikaner be expedited the event of establishment of a new University at Udaipur.

Reporting Government order No.F.1(1) Karmik (K-4) 99, dated 18.4.1999, posting Sh.S.K.Shrimali, RAS as Registrar of this University, Vice Sh.G.L.Suthar, RAS.

The Board confirmed the above order & extended a cordial welcome to Shri S.K.Shrimali, RAS and hoped that Shri Shrimali would greatly contribute for the development of the University.

Considering the progress report in respect of faculty improvement programme, civil works and procurement of equipments made under World Bank assisted Agriculture Development Project.



The Board agreed in principle to absorb Dr.Jyote Prasad Mathur in University since he is serving for the last 14 yrs.

Dr.Mathur is M.Sc. in Zoology and Ph.D. in the related field of Zoology and therefore possibilities be explored to utilise his services in the Deptt. of Limnology & Fisheries on the post for which Dr.Mathur is qualified.

It was further resolved that this will not form precedent for future.

AU/BOM-42/99-2/753      Considering fee bill of Rs. 20,000/- raised by Sh.P.P.Rao Sr.Advocate for appearance and Conference in the special leave perition No.20466/97/ RAU V/s H.C.Sankhla on 13.07.1998 in Supreme Court of India.

Resolved that in addition to Rs. 15,000/- already paid to Shri P.P.Rao, Sr. Advocate approved earlier by Board of Management in its meeting held on 28.09.1998, balance amount of Rs.5,000/- be also paid against his bill No.845/98-99 dated 13.7.1998 of Rs. 20,000/- for appearance and conference in the Supreme Court of India in S.L.P. No. 20466/97-RAU V/s H.C.Sankhla.

Member's were of the opinion that possibilities be explored to have Standing counsels in Supreme Court of India.

AU/BOM-42/99-2/754      As per recommendation of SDP for RAU considering the guidelines for grant of individual & institutional consultancy to the faculty members of RAU.

The guidelines for individual and Institutional Consultancy for Rajsthan Agricultural University was presented by Director, Planning & Monitoring, which were approved with the following modifications:

The term of the Advisory Committee shall be for a period of three years.

### 1.5.2. Competent authority to approve consultancy:

Any proposal of consultancy with foreign agency has to be approved by the Board of Management.

Consultancy for all National Agencies shall be approved by the Director Research/Dean.

After the consultancy work is over a final report will be submitted to the Board of Management giving detailed technical and financial information.

AU/BOM-42/99-2/755      Considering authorising the Vice-Chancellor to grant further extension for a period of three months to those retired employees whose re-employment/contract period is expiring on 30.6.1999.

In the light of the decision of the Govt. not to give extension to retired employees the members were of the view that after getting permission from DOP Vice-Chancellor may grant extension only in cases where it is absolutely necessary.

AU/BOM-42/99-2/756      Considering approval of the following proposals communicated to the State Govt. for consideration before NRC on Seed Spices is shifted by ICAR to ARSS Tabiji (Ajmer).

- i. While surrendering the land of ARSS Tabiji, ICAR be asked to provide Rs. 3.50 lacs for constructing a new tube well in lieu of the tube well installed by RAU.
- ii. Money provided by ICAR to the State Govt. in lieu of surrendering Pacca Stone Boundary wall running in about 1000 meters on account of providing 28 acres of land of ATC for NRCSS, be made available to RAU for making earth bund/retention wall/pacca wall/levelling & development of experimental fields. This is necessary since after surrendering 23.9 acres of land of ARSS Tabiji for NRCSS 40% of the remaining 46.6 acres of land with ARSS Tabiji gets inundated from rainy Nala draining lakes and city of Ajmer.



- iii. Out of the 50 acres of land of Tabiji Farm transferred by State Govt. on 15th March'77 to Ajmer milk producer Co-Operative Union 6 acres, land which is a separate pocket surrounded by RAU land and is not being put to any useful purpose for long, be transferred back to RAU.

Resolved that action taken by the Vice-Chancellor in communicating the above proposals to the State Govt. vide letter No. F.P.S/VC/RAU/99/173 dated 26.4.99 be confirmed.

ICAR and State Govt. be requested to expedite approval of these proposals before NRC on Seed Spices is shifted by ICAR to ARSS Tabiji (Ajmer).

AU/BOM-42/99-2/757

Considering minutes of the meeting of the Finance committee held on 21.6.1999.

Resolved that recommendations of the Finance Committee meeting held on 21.6.99 be approved except Item No. 10 in which it has been recommended that R.E. 1998-99 & B.E. 1999-2000 be recast after :

- (i) Total liabilities due to revision of UGC pay scales is depicted in the budget which is approx 3242.00 lacs out of which 2593.60 lacs (80%) is ICAR share and Rs. 648.40 lacs (20%) is State share.
- (ii) Liability of 237.00 lacs which could not be paid during the year 1998-99 due to non-receipt of funds from the ICAR is shown under the respective budget heads and put up in next meeting of Finance Committee.

Considering Revised Estimates 1998-1999 and Budget Estimates 1999-2000 as recommended by the Finance Committee in its meeting held on 21.6.99.

Resolved that Vice-Chancellor be authorised to approve R.E. 1998-99 & B.E. 1999-2000 after it is recasted as per direction of Finance Committee as under:

- (i) Total liability due to revision of UGC pay scales is depicted in the budget.
- (ii) Liability of Rs. 237.00 lacs which could not be paid during 1998-99 due to non-receipt of funds from the ICAR be shown under the respective heads.
- (iii) ADP project is reflected in the budget.

Further resolved that serious efforts be made to generate more farm income. Expressing their concern about deficit in the budget all the members were of the view that KVK/ ARS should be self sufficient. Their contingencies and other expenditure should be met out from their own income. Target of income generation should be fixed by the Director concerned. Use of the unutilised land of KVK's & ARS should be made. There must be regular monitoring of economic viability of the ARS, ARSs & KVK's. This should be discussed in the next meeting of BOM. In veterinary also the Dean, CVAS & Director (Vet.) should ensure that the demand of fodder & feed is met from their own fields.

The following committee be appointed to prepare modes-operandi for generating more income from University farms :

1. Director of Agriculture, Govt. of Rajasthan, Jaipur ( Chairman)
2. Director Research(Agri.) RAU,
3. **Prof. R.K. Sharma** Dean, PCS, RAU, Bikaner

The above committee shall submit its recommendation early.

Considering abolition of the provision of Revaluation of answer books in theory papers of the Final University Examination of RAU.

Resolved that existing provision of re-valuation of answer books in the theory papers of the final University examination of RAU be dispense with & re-evaluation be limited to :

- (i) Re-totalling of marks obtained.
- (ii) Re-marking of any Question left from marking.

This will come into force with immediate effect.



Resolved that proposals submitted by the committee appointed by the State Govt be noted.

It was however desired that immediate requirement of both Bikaner and Udaipur Campus be submitted to Government, in case if the new Agricultural University at Udaipur becomes functional in July '99.

With reference to Resolution No. AU/BOM-41/98-2/733 dated 4.3.99 of the Board of Management considering a comprehensive note submitted to Vice-Chancellor by Prof. A.K. Gahlot in connection with implementation of Resolution No. AU/BOM-40/98-2/723 dated 28.9.98 regarding declassifying the post of Vety. Asstt. Surgeon/ Vet. Instructor/ Technical Officer as dying cadre & revising their nomenclature as Asstt. Professor.

Resolved that in future recruitment of Veterinary instructor's, Veterinary Asst Surgeons and technical officer be worked out separately and qualification for the post of Veterinary instructor's be prescribed as M.V.Sc.. The office order No RAU/Estt./GR-I/ 98/ 1796-1800 dated: 17.11.98 be amended accordingly.

Resolved that consideration be Deferred.

Considering D.O. letter No. PS/PSC/NETSLET/99/ dated 9/10.6.99 received from the Principal Secretary to government, Rajasthan, Jaipur to send the views of the University as to whether NET requirement be kept essential for the candidates possessing Ph.D. degree for the post of Assistant Professor, since in the University Grants Commission guidelines while allowing revised pay scales, it has been indicated that it would

be optional for the University to exempt Ph.D. holder's from NET or to require NET either as a desirable or essential qualification for appointment in the University departments and Colleges.

It was pointed out that State Agriculture Universities are guided by guidelines issued by ICAR and not UGC. Therefore Principal Secretary to H.E the Chancellor be informed of the direction of ICAR in this regard.

Considering to constitute a G.P.F. Committee to advise the BOM in matters relating to investment payments and other matters in respect of G.P.F and to declare the rate of interest for the year 1991-1992 to 1998-1999 to be paid to the G.P.F. subscribers.

Considering D.O. letter No.1(1)/96 Edn.II dt.12.4.99 received from Director General Indian Council of Agriculture Research addressed to the Chief Secretary, Govt. of Rajasthan to ensure proper implementation of the Model Act in Rajasthan Agricultural University in the larger interest of agricultural research & education in the country.

Resolved that consideration be Deferred.

AU/BOM-42/99-2/766

Considering following recommendation of the Research Advisory Committee made in its meeting held on 06.05.1999.

"Original NARP Zone Ia Bikaner, Jaisalmer, Barmer & parts of Jodhpur & Churu Districts be continued covering the areas of Zone I-c Bikaner, Jaisalmer & Four Tehsils of Dungargarh, Sujargarh, Ratangarh & Sardar Shahar of Churu District & ARS Beechwal with all its infrastructure & manpower be named as CRC, Beechwal."

Resolved that above recommendation of the Research Advisory Committee made in its meeting held on 06.05.1999, be not agreed and Status-quo be maintained. Zone Ic comprising of Bikaner, Jaisalmer and four tehsils of Dungargarh, Sujargarh, Ratangarh & Sardar Shahar of Churu district be continued to operate, as such.

Considering the request of Dr. Aminuddin, Assoc. Professor (Under Career Advancement Scheme) for grant of Leave Without Pay from 1.6.99 to 31.5.2001 for taking employment at N.R.C.C., Bikaner as Senior Scientist (Animal Production).

Resolved that services of those teacher's who have put in more than 10 yrs of service after their regular selection in RAU be treated as permanent for the purpose of granting them benefit of leave without pay for employment outside the Universities under rule 82(a) of the teacher's and officer's service condition rules.

Further Dr. Aminuddin, Assoc. Prof. (Under Career Advancement Scheme) be granted L.W.P. for a period of 2yrs (1.6.99 to 31.5.2001) for taking employment at N.R.C.C., Bikaner as Senior Scientist (Animal Production). During the period of leave without pay lien of Dr. Aminuddin shall be retained on the post of Assoc. Prof. (Under Career Advancement) Obst. & Gynaecology, CVAS., Bikaner.

The amended rules will come into effect from 1st July, 1999.

Before the meeting was concluded member expressed their concern about the delay in payment of retirement benefits to the employees of RAU, and it was decided that claims of those employees retired during the last three months be finalised within 15 days positively otherwise responsibility be fixed on the defaulting officer. As regards change of option from PF to Pension & vice versa it was decided that the matter may examined and placed before Board of Management during next meeting.
