AU/BOM-53/2003-2/894

**To confirm the proceedings of the meeting of the Board of Management held on 15.1.2003**

Resolved to confirm the proceedings with the observations pertaining to Item No.AU/BOM-51/2003-1/874 (ii)(a) dated 15.1.2003 "Mention of item No.AU/BOM-48/2001-02/852 dated 20.10.2001 in item no.AU/BOM-50/2002-2/856 dated 15.6.2002 that it would be reconsidered in the next meeting of BOM on the basis of the report of the committee to be constituted by Hon'ble Vice-Chancellor under his chairmanship to examine the complaints and representations received from Hon'ble Chancellor, Govt. of Rajasthan I.C.A.R., teachers & different Associations.

Proceedings of the committee constituted for examining the complaints received from the different quarters regarding implementation of CAS 2001 submitted before the members of the Board of Management. It was resolved that all attempts should be made by the University Administration for the redressal of the grievances of Scientists to get them reassessed after taking necessary permission from the different concerned quarters.

**To consider the Action taken report of meeting dated 15.1.2003**

Resolved to confirm the following observations:

The minutes of the meeting of the Sub-committee constituted in compliance of BOM Resolution No.AU/BOM-50/2002/867, AU/BOM-51/2003/879, 889 and 892 dated 15.1.2003 were submitted before the members of the BOM. It was resolved that:

1. AU/BOM-50/2002/867 : To formulated a promotion policy for STA's who are already working in the pay scale of Rs.8000-13500.

The issue was considered by the Committee and it was felt that STA cadre can not be merged with the teaching. However, it may be referred to the Govt. if possible to adopt the pattern of ICAR for five yearly assessment of STA's.

2. AU/BOM-51/2002/879 : To consider the promotion proposal on the post of Addl.Registrar /Dy.Registrar/Accounts Officer / Asstt.Registrar

may be done from Section Officers/Sr.P.A. against the post of direct recruitment where vacancies exist.

This matter was also discussed and it was resolved that pattern existing in Secretariat, Govt. of Rajasthan for promotion to the post of Addl.Registrar/Dy.Registrar/Accounts Officer/ Asstt. Registrar be followed with due approval of Govt. of Rajasthan.

3. (a) AU/BOM-51/2003-1/889 : To consider the representation of the RAUTA letter No. RAUTA/RAU/02/334 dated 23.10.2002 regarding the matter of lecturers for considering their undermentioned cases in the light of the recent judgement of High Court:

- (i) To consider and count the services of lecturers for allowing them senior/selection scale under the CAS:

The committee members discussed and informed that matter is subjudice, as such no decision was taken.

- (ii) To consider and count the adhoc services of Assistant Professors for the senior/selection scale under the CAS:

It was resolved that issue may be referred to the Govt. for counting the adhoc services for personal promotion.

4. AU/BOM-51/2003-1/992 : To consider the proposal of RAUTA, Bikaner submitted vide letter dated 12.1.2003 and No.RAUTA/02/347-67 dated 10.1.2003 for giving advantage to eligible teachers under the CAS Scheme-2001 and to maintain their seniority on the pattern adopted by the MPUAT, Udaipur in respect of their teachers.

It was resolved that this issue should be dealt as per the existing rules and provisions.

- (5) Regarding action taken of BOM Resolution No. AU/BOM-50/2002/870, it was resolved that deputation of Sh.Surdeep Singh, Dy.Registrar may be continued till further order.

Hence, it is resolved that Mr.Rana be allowed Senior Scale w.e.f. 12.11.87 and Assoc. Prof. w.e.f. 12.11.95.


**To consider the request of the teachers association for counting the Adhoc service of the lecturers for their pensionary benefits.**


