Subject : Admissibility of Assured Career Progression (ACP)
Scheme under the Rajasthan Civil Services
(Revised Pay) Rules, 2008.

1. The Scheme of Assured Career Progression (ACP), with three financial upgradations, was made applicable with effect from 01.01.2006 under Rajasthan Civil Services (Revised Pay) Rules, 2008 vide notification No. F.11(7)FD/Rules/2008 dated 12.09.2008 and as further amended vide notification No. F.11(7)FD/Rules/2008Pt.I dated 06.10.2008 and notification No.F.14(1)FD/Rules/2013-II dated 06.04.2013. Financial upgradation was allowed, under this scheme in the immediate next higher grade pay in the hierarchy of Running Pay Bands and Grade Pays.
2. The grade pays, as originally fixed vide notification dated 12.09.2008 were subsequently changed as per notification No. F.14(1)FD/Rules/2013-II dated 28.06.2013 made effective from 01.07.2013. In view of changes made in running pay band and grade pays, Finance Department vide Memorandum No. F.14(88)FD/Rules/2008 dated 05.07.2013 prescribed the admissibility of ACPs in the following manner:-

3. The grade pays revised vide notification dated 28.06.2013 were again modified vide notification No. F.14(1)FD/Rules/2013 dated 30.10.2017 w.e.f. 01.07.2013. In view of these modified grade pays, the revised ACPs being allowed are as under:-

4. The matter, regarding grant of ACPs, has been examined and the State Government has decided to amend the scheme of grant of financial upgradation under ACP scheme in the following manner :-



Subject : Admissibility of Assured Career Progression (ACP)
Scheme under the Rajasthan Civil Services (Revised
Pay) Rules, 2017.


1. The Scheme of Assured Career Progression (ACP), as introduced under the Rajasthan Civil Services (Revised Pay) Rules, 2008, has been continued in the Rajasthan Civil Services (Revised Pay) Rules, 2017. The Rules-14 and 15 of Rajasthan Civil Services (Revised Pay) Rules, 2017 contain the modalities and conditions for grant of ACP. Schedule-VI appended to these rules, contains the guidelines for grant of Assured Career Progression Scheme to State Government Employees.
2. The matter regarding grant of ACP to the State Government employees has been examined and amendment in the admissibility of ACPs under Rajasthan Civil Services (Revised Pay) Rules, 2008 has been issued vide Memorandum No. F. 14(88)FD/Rules/2008 dated 27.02.2022 In view of the corresponding changes required for grant of ACP under Rajasthan Civil Services (Revised Pay) Rules, 2017, the State Government has decided to amend the scheme of grant of Assured Career Progression Scheme as contained in Rajasthan Civil Services (Revised Pay) Rules, 2017. The ACP under these rules would be admissible in the following manner:-

3. Under Rajasthan Civil Services (Revised Pay) Rules, 2008, GP No. 15 with grade pay of Rs. 5400 is in PB-2 and also in PB-3. The GP 5400 in PB-2 was kept for grant of ACP only. The next ACP for GP 5400 of PB-2, was GP 6000 having grade pay No. 16. Taking the same analogy under Rajasthan Civil Services (Revised Pay) Rules, 2017, the next ACP pertaining to pay level L-13 would be pay level L-15 instead of pay level L-14.
4. These dispensations would be applicable with effect from 01.01.2016.
5. The ACP provisions contained in Rules-14 and 15 of Rajasthan Civil Services (Revised Pay) Rules, 2017, including the guidelines given in Schedule-VI, will be treated as amended accordingly.
