

(Action: - Faculty Chairperson Agriculture / CCS & Director, IABM)





To review the progress in the 10 Attributes of NAAC Binary Accreditation by different committees constituted for this purpose at University level, a meeting was held on 21.10.2024 at 4.00 pm in the VC Secretariat in the Chairmanship of Hon'ble VC Sir Dr. Arun Kumar.

Dr. Sujit Kumar Yadav and Dr. Seema Tyagi attended a Training Workshop at NAARM Hyderabad (Oct. 16-18, 2024) on NIRF and NAAC Accreditation and shared their learning experiences in the house. Dr. Sujit Kumar Yadav, Convenor Technical Cell gave PPT presentation on the procedural updates to fill the Data Templates and their proofs.

The following observations and action points were suggested during the meeting:

1. The NAAC Accreditation will require the Research Publications in peer reviewed journals listed in SCOPUS/WoS/UGC Care list. For this, a sensitization programme should be conducted for all the faculty members of the university including PG & Ph.D. students to increase the number of publications in peer reviewed journals listed in SCOPUS/WoS/UGC Care list.

**Action: Director Research**

2. VIDWAN is the premier database of profiles of scientists/researchers and other faculty members working at leading academic institutions and other R&D organisation involved in teaching and research in India. Therefore, there is a need to create this ID for all the faculty members of the University. Dr. Sujit Kumar Yadav will facilitate the faculty to create their VIDWAN ID who do not have this ID.

**Action: Dr. Sujit Kumar Yadav, CIMCA Incharge**

3. In order to improve and enhance the perception of the University, the social media like Face Book, Twitter, YouTube Accounts of the University should be made more active to give wide coverage of University news and events for visibility of day to day activities.

**Action: PRO Sh. Suresh Bishnoi**

4. The attribute dealing with Curriculum requires inputs on curriculum design received from the Employers/Industry stakeholders that need to be analyzed and incorporated in the curriculum. For this, the persons from industry should be invited in the BoS.

**Action: Dean CoA Bikaner/Dean CCS/Director IABM**

5. The lecture notes of all the programmes running in Agriculture, Community Science & Agri-Business Management colleges should be uploaded up on university website.

**Action: CIMCA Incharge/ Dean CoA Bikaner/Dean CCS/Director IABM**

6. The proceedings of Credit seminars, Synopsis seminars and Pre & Post thesis seminars need to be prepared along with Geo-tagged photographs for keeping record under their respective colleges IQAC.

**Action: Dean PGS/ CoA Bikaner/Dean CCS/Director IABM**

7. Blood Donation Camp to be held in the University HQ with the participation of all units.

**Action: DSW**



8. In the RAC meetings, the different stakeholders like farmers, Agri-input providers must be invited.

**Action: Director Research**

9. Each unit of the University should plan one year activity calendar highlighting the events to be conducted, introduction of new courses, new product development etc.

**Action: All Deans/Directors/Unit Incharges**

10. The constituent Colleges of the university will call their IQAC meetings and submit their proceedings to Director PM&E.

**Action: All Deans/Directors/Unit Incharges/Director PM&E**

11. The group insurance scheme for all the students of our university must be done.

**Action: DSW**

12. A University Level 'Job Fair' is to be conducted for all the final year students of the university by end of December 2024 to provide a platform for employment opportunities.

**Action: DSW**

13. All the constituent colleges must develop a Google Form to keep track of their passing out students going for employment and higher educations. For this the three years data must be documented through the student section of each college.

**Action: Dean CoA Bikaner, SGNR, HNG, Chandgothi,  
Mandawa/Dean CCS/Director IABM**

14. Pre-seasonal technology dissemination programme must be taken up Zone-wise with the onset of Crop season.

**Action: Director Research**

15. Hackathon must be organized at University level for getting good weightage in NAAC Accreditation and NIRF Ranking.

**Action: Dean CoA Bikaner/Dean CCS/Director IABM**

16. Since NAAC has a provision of incorporating Indian Knowledge System (IKS) and its promotion through Workshops/seminars, Certificate Courses on IKS, Components of IKS in core curriculum, Promotion of student/faculty projects and researches in IKS, Centre for IKS, the faculty needs to be sensitized to start working on this domain.

17. For establishment of IKS Centre, Dr. Rajesh Verma will document the different activities conducted by KVKs/Colleges of the university and display at IKS centre at University HQ.

18. For the collection of Feedback on Curricular aspect, Director PM&E will develop Feedback proforma for different stakeholders and circulate to all constituent colleges. After taking feedback, it should be analysed and action taken is to be ensured with approval of Academic Council/BoS.


20. PhD students will publish research papers in SCOPUS/WoS/UGC Care journals for award of their degrees.
