3. Quotations received after the prescribed time and date will be rejected.
4. On the cover containing the quotation it should be mentioned as **“Quotation for Supply and installation of Air Conditioner with all accessories due on 28.02.2025”**
5. The undersigned is not bound to accept the lowest amount of tender.
6. Quotations should be filled in ink and corrections, if any are made, should be duly countersigned.
7. Remittance charges on payment to the firms shall have to be borne by the firm.
8. **NO ADVANCE PAYMENT WILL BE MADE.**
9. All legal proceedings, if any by any party shall have to be lodged in a court situated in Bikaner and not elsewhere. All disputes are subject to Bikaner jurisdiction only.
10. Supply of goods will have to be made within 07 days.
