1. ARS Sriganaganagar invites tenders for supply of Leaf Chlorophyll and Nutrient Tester as per specifications given.
2. The bidders are requested to read the tender document carefully and ensure all the compliance with instructions herein. Non-compliance of the instructions contained in this document may disqualify the bidders from the tender process.
3. All offers should be written in the English. The offer should be typed or written in pen ink or ball pen. The tenderer shall certify that the rates being quoted are not higher than those quoted for any Govt. Dept. or Institution or DGS & D or any organization and that if during the years at any time the tenderer has quoted rates lower than those quoted against this tender, the ARS would be given the benefit of lower rates by the tenderer..
4. The prescribed tender documents should be submitted in one sealed envelope duly superscribed with "Supply and demonstration of Leaf Chlorophyll and Nutrient Tester to the ARS Sriganaganagar".
5. The last date of tender receiving is 17.03.2025 up to 01:00 PM and same will be opened on 17.03.2025 at 02:00 PM.
6. The complete tender document is to be signed with seal & is to be placed in the separate envelopes along with the necessary required documents.
7. The duly constituted committee appointed by the competent authority of ARS Sriganaganagar, reserves the right to select the items. The same committee will also reserve the right to revise or alter the specifications before acceptance of any tender with prior notice.
8. Incomplete tenders, amendments and additions to tender after opening or late tenders are liable to be ignored and rejected.
9. Prices stated in this tender are firm and shall remain firm until required deliveries have been completed. All prices specified herein include all charges for, but not limited to, inspection, and packaging. Prices set forth shall be inclusive of GST.
10. The equipment should be delivered and demonstrated at ARS Sriganaganagar and within a time period of 10 days from the date of opening. The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination as indicated in the Contract. The packing shall be

sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit and open storage. It is the sole responsibility of the vendor to provide/replace the item/goods, if it is lost or broken during the shipping or transportation due to whatever may be the reason.

11. Material procured from vendor shall be inspected and tested by the subject experts. If any Material covered by this agreement is defective or otherwise not conforming the requirements of this agreement, the ARS will not accept the item.
 12. After completion of supply/purchase order, the Vendor shall send duplicate invoices to the ARS Sriganaganagar. Suppliers must attach necessary documents and certificates operating manual from manufacturer in case of dealer/s for the said equipment enclosed with the technical specifications etc.
 13. Tender must be delivered to the above office up to the date and time indicated above. Bids will be opened in the presence of Bidders' authorized representatives who choose to attend on the specified date and time. In the event of the date specified for bid receipt and opening being declared as a closed holiday for purchaser's office, the due date for submission of bids and opening of bids will be next working day. Please Note that the tender document is subjected to verification with the original document and if any discrepancy is found, the tender would be rejected.
