Dear Vice Chancellor Colleagues.

Greetings from the ICAR!!

It is a matter of pride that your university is an important and integral part of the ICAR-Agriculture University (AU) system and working in tandem with the ICAR for providing the quality education, research outcome and extension services to the stakeholders. As you are aware, it was mutually agreed that 15% (now 20%) of the undergraduate (UG) sents under the ICAR quota in your university will be filled based on the All-India Competitive Examination being conducted by ICAR and the same is in practice for more than 25 years. Also, I understand that the agriculture and agriculture education are State subjects as per the Constitution and governed largely by the State Govt, policies with targeted welfare of the respective State stakeholders. The ICAR while conducting the All-India Entrance Examination (now Common University Entrance Test-CUET) through National Testing Agency (NTA) for the ICAR seats (20%) in AUs; the eligibility of subject Agriculture/Inter-agriculture besides core subjects of Physics, Chemistry, Biology and Mathematics in 12th standard, is also considered. While inviting the seat matrix of UG programs from AUs and essential subject eligibility for admission, many AUs are not according due importance to the candidates with subject Agriculture Inter-agriculture. The inclusiveness of candidates from the states offering Agriculture/Inter-agriculture in 12th standard needs to be considered in the larger National interest. Therefore, kindly take up the issue and ensure corrective steps in this direction without disturbing the State welfare and creating unnecessary legal hurdles.

I am hopeful that positive and pragmatic interventions on your part in inclusion of subject Agriculture/Inter-Agriculture as an essential subject eligibility in your AU for admission to UG programs, under the ICAR quota seats, will be immensely beneficial to the candidates with subject Agriculture inter-Agriculture in the 12th standard. An early response to the matter will help in implementing the eligibility from the current session.

Application form fee is to be deposited online only. This is non-refundable/non-transferable/non-adjustable in any case.

Before filling online option form, candidate may go through the ICAR guidelines for accreditation and other credentials of Universities and Institutes.

2.0 ELIGIBILITY CRITERIA FOR ADMISSION

A candidate must ensure that he/she is eligible for admission to the desired course before filling the online application form for JET as detailed in the JET booklet. Applying for JET, appearing in the examinations, allotment of the college and qualifying for the same does not necessarily mean acceptance of eligibility. If a non-eligible candidate is admitted due to any reason, then the allotment or admission of such a candidate will be cancelled as soon as the mistake is detected even at later stage. Various eligibility criteria for admission through JET are as under: -

2.1 EDUCATIONAL QUALIFICATION

The candidates who have passed the Senior Secondary (10+2) examinations conducted by the Board of Secondary Education Rajasthan, Ajmer or any other Statutory Board or any examinations recognized equivalent to by the university in any of the combinations of following subjects in Science/Agriculture stream are eligible to appear in JET:

Agriculture (A), Biology (B), Chemistry (C), Mathematics (M) and Physics (P) *i.e.* ABC or PCM or PCB or PCMB or PCA

For Admission to B.Tech. (Food Technology): Out of combination of Agriculture (A), Biology (B), Chemistry (C), Mathematics (M) and Physics (P), only PCM or PCB or PCMB or PCA will be eligible.

For Admission to B.Tech. (Dairy Technology): Physics, Chemistry and Mathematics (PCM) subjects are essential at 10+2 level.

Candidate has to attempt three subjects in JET examinations of his/her 10+2 stream only out of the above five subjects *i.e.* Agriculture, Biology, Chemistry, Mathematics and Physics.

Those who want admission to B.Tech. (Dairy Technology) do not have any choice and must attempt only PCM (Physics, Chemistry & Mathematics).

2.0 प्रवेश लेने हेत् पात्रता मानदंड

अभ्यर्थी जेट ऑनलाइन आवेदन पत्र भरने से पहले ये सुनिश्चित कर लेवें कि वह वांछित कोर्स में प्रवेश लेने के योग्य है, जैसा कि जेट पुस्तिका में विस्तृत हैं। जेईटी के लिए आवेदन करना, परीक्षाओं में शामिल होना, कॉलेज का आवंटन और उसके लिए अईता प्राप्त करने का मतलब पात्रता की स्वीकृति नहीं हैं। यदि किसी कारणवश किसी अयोग्य अभ्यर्थी को प्रवेश दे दिया जाता है तो पता चलते ही उसका आवंटन अथवा प्रवेश तुरन्त रदद् कर दिया जायेगा। जेट के माध्यम से प्रवेश पाने हेतु योग्यताएँ निम्नानुसार है:--

2.1 शैक्षणिक योग्यता

जिन अम्यर्थियों ने उच्च माध्यमिक (10+2) परीक्षा, राजस्थान माध्यमिक शिक्षा बोर्ड, अजमेर या इसकें समकक्ष अन्य बोर्ड या विश्वविद्यालय से विज्ञान / कृषि संकाय के निम्न विषयों में उत्तीर्ण की हो, वह संयुक्त प्रवेश परीक्षा (जेट) में बैठने के पात्र होंगे:

कृषि, जीव विज्ञान, रसायन विज्ञान, गणित व भौतिक विज्ञान के विभिन्न संयोजन जैसे ABC या PCM या PCB या PCMB या PCA.

बी.टेक. (फूड टेक्नोलॉजी) में प्रवेश लेने हेतु कृषि, जीव विज्ञान, रसायन विज्ञान, गणित व भौतिक विज्ञान के विभिन्न संयोजन जैसे PCM या PCB या PCMB या PCAपात्र होंगे।

बी.टेक. (डेयरी टेक्नोलॉजी) में प्रवेश लेने हेतु रसायन विज्ञान, गणित व भौतिक विज्ञान में 12वीं (10+2) कक्षा पास होना आवश्यक है।

अभ्यर्थी संयुक्त प्रवेश परीक्षा के लिए पांच विषयों कृषि, जीव विज्ञान, रसायन विज्ञान, गणित व भौतिक विज्ञान में से कंवल उन्हीं तीन विषयों का चुनाव कर सकता है जिन विषयों में अभ्यर्थी ने 10+2 की परीक्षा

बी.टेक. (डेयरी टेक्नोलॉजी) में प्रवेश लेने हेतु अभ्यर्थी को केवल रसायन विज्ञान, गणित व भौतिकी के ही पेपर करने अनिवार्य हैं।
