The State Government has constituted Search-cum-Selection Committee for selection of Vice Chancellor in the **Dr. Yashwant Singh Parmar University of Horticulture & Forestry, Nauni (Solan)**, vide notification No. AGR-B-A(3)-2/2025 dated 06.01.2026 as per the provisions of Rule-5 of the Himachal Pradesh Universities of Agriculture, Horticulture and Forestry Rules, 2026 for recommending a panel of names for the appointment of a regular Vice Chancellor of the University.

The Vice Chancellor of the Dr. Yashwant Singh Parmar University of Horticulture & Forestry, Nauni (Solan) (a State Funded University of Himachal Pradesh) is a whole time paid officer of the University (Rule-2 of the Himachal Pradesh Universities of Agriculture, Horticulture and Forestry Rules, 2026) and shall be appointed by the Chancellor on the aid and advice of the State Government upon recommendation of the Search- cum-Selection Committee constituted by the State Government for this purpose. The term of the office of the Vice Chancellor shall be three years from the date on which he or she enters upon his or her office or until he or she attains the age of 65 years, whichever is earlier, along with other terms of service as per Rule-5 of the Himachal Pradesh Universities of Agriculture, Horticulture and Forestry Rules, 2026 (available on University website mentioned below) prescribes-

"No person shall be eligible to be appointed as Vice-Chancellor unless he is, a distinguished academician with minimum of 10 years of experience as Professor, or equivalent in University or Research Institutions, has high academic standards, integrity and administrative experience, preferably in agricultural, horticultural, forestry, or allied sciences; including 20 years service in Agriculture research services and should meet other qualification notified by the State Government from time to time."
